Jayne Thomas Grassroots Volunteer Recognition Award

Named in honor of Jayne Thomas, a preeminent Community Action leader in Virginia, this award was established in 1988 to recognize and honor volunteers who are devoted to changing people's lives and who have made a significant and outstanding contribution toward accomplishing the promise of Community Action.

Sargent Shriver Achievement Award

Named in honor of Sargent Shriver, the first Office of Economic Opportunity Director. This

award was established in 1995 to recognize and honor the accomplishments of individuals who, with the assistance of a Community Action Agency, have changed their lives by achieving economic stability, self-sufficiency and independence, and then have gone on to help others turn their hopes into reality by improving their communities through advocacy, volunteerism, public service, or some other vehicle.

Grant Opportunity: Supporting Policy Change

The Policy Campaign Grant opportunity from Voices for Healthy Kids aims to fund strategic issue advocacy campaigns focused on helping kids grow up healthy through state, local, and tribal public policy campaigns. Applications must be specific to an individual campaign for public policy change in one state, local or tribal geographic location and address one of the policy levers supported by our initiative. Voices for Healthy Kids is allocating grants up to \$250,000 per award for a period of up to one year. Please note awards will be very competitive and applicants are encouraged to apply for the funds they need and not always the maximum allowed. Applicants working on policy campaigns are able to allocate up to 20% of their budget for lobbying tactics. Letters of Intent are due by June 7, 2019.
